The directors are responsible for the maintenance and integrity of the corporate and financial information included on the company's website.



INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF JERSEY CITIZENS ADVICE BUREAU LIMITED

Opinion

We have audited the financial statements of Jersey Citizens Advice Bureau Limited (the "company") for the year ended 31 December 2022 which comprise the Income and Expenditure account, Balance Sheet and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland.

In our opinion, the financial statements:

Matters on which we are required to report by exception

We have nothing to report in respect of the following matters in relation to which the Companies (Jersey) Law 1991 requires us to report to you if, in our opinion:

Based on our understanding of the company and its environment, together with discussion with senior management where appropriate, we were able to identify those laws and regulations which would have a direct effect on the financial statements as well as those which may have an effect on amounts in the financial statements, for instance through the imposition of fines or litigation. These included, but were not limited to, Jersey Company Law as well as general legislation applicable to a business operating in Jersey, such as Data Protection requirements, Employment Law and Health and Safety Regulation. The risks arising from these laws and regulations were discussed amongst the audit engagement team, including consideration as to how and where fraud might occur.

Based on our assessment, the Engagement Partner ensured that the audit engagement team was composed appropriately with suitable competence and capabilities in order to allow identification and recognition of non-compliance with laws and regulations. The risks identified were communicated to all engagement team members who remained alert during the course of the audit for any indication of irregularities, including fraud.

Our procedures in response to the risks identified included the following:

- Enquiry of management, including consideration of known or suspected instances of non-compliance with laws and regulation or fraud;
- Review all available minutes of meetings held by those charged with governance;
- Performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatement due to fraud;
- In common with all audits carried out under the ISAs(UK), we carried out procedures in response to the threat of management override, including those considering the appropriateness of journal entries and judgements made in making accounting estimates;
- Review for any changes to activities which the company undertakes;

There are inherent limitations in the audit procedures above and, the further removed non-compliance with laws and regulations is from the events and transactions reflected in the financial statements, the less likely we would become aware of it. 



NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 DECEMBER 2022

1. GENERAL INFORMATION

Jersey Citizens Advice Bureau Limited is a company limited by guarantee and incorporated in Jersey, Channel Islands. The company's principal place of business, which is also its registered office, is The Annexe, St Pauls Community Centre, New Street, St Helier, Jersey JE2 3WP. The principal activity of the company is described in the report of the directors.

2. ACCOUNTING POLICIES

The principal accounting policies are summarised below. They have been applied consistently throughout the year and to the preceding year.

2.1 Basis of accounting

The financial statements have been prepared on a going concern basis under the historical cost convention in compliance with applicable United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ('FRS 102'), adopting the disclosure and presentational requirements of Section 1A Smaller Entities, and Companies (Jersey) Law, 1991, as amended.

2.2 Grants

Grants are brought to the credit of income and expenditure account when they are due to the company.

2.3 Income

Income arising from donations and bank deposits are brought to the credit of the income and expenditure account when due to the company.

2.4 Donated assets and donations in kind

Donated assets are recognised at cost and credited in the period when entitlement to the assets is known.

Donated services are included as part of 'Donations' at their estimated value to the company when received, and under the appropriate expenditure heading depending on the nature of service provided, at the same value and time.

2.5 Depreciation

Depreciation is charged in all fixed assets on a straight line basis, calculated to write each asset down to its estimated residual value over its expected useful life at the following annual rate:

2.6 Volunteers

A great amount of time is donated during the year by the many volunteers, the value of which is not reflected in these financial statements.

2.7 Financial Instruments

The company has chosen to adopt Sections 11 and 12 of FRS 102 in respect of financial instruments.

(a) Financial assets

Basic financial assets, including trade and other receivables and cash and bank balances, are initially recognised at transaction price, unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at the market rate of interest.

Such assets are subsequently stated at amortised cost using the effective interest method.

Such assets are subsequently carried at fair value and the changes in fair value are recognised in profit or loss, except that investments in equity instruments that are not publicly traded and whose fair values cannot be measured reliably are measured at cost less impairment.

(b) Financial liabilities

Basic financial liabilities including trade and other payables and bank loans are initially recognised at transaction price, unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future receipts discounted at a market rate of interest.

Debt instruments are subsequently carried at amortised cost using the effective interest method.

(c) Impairment

At the end of each reporting period financial assets measured at amortised cost are assessed for objective evidence of impairment. If an asset is impaired the impairment loss is the difference between the carrying value and the present value of the estimated cash flows discounted at the asset's original effective interest rate. The impairment loss is recognised in profit or loss.

If there is a decrease in the impairment loss arising from an event occurring after the impairment was recognised the impairment is reversed. The reversal is such that the current carrying amount does not exceed what the carrying amount would have been had the impairment not previously been recognised. The impairment reversal is recognised in profit or loss.

The current lease which runs till November 2026 included a break clause which could have been exercised during 2022 allowing the lease to have been terminated. This option to break has not been exercised.

8. AVERAGE NUMBER OF EMPLOYEES DURING THE YEAR

The average number of employees of the company during the year was 6. (2021: 6). All directors of the company are non-executive unpaid directors and they, along with all other unpaid volunteers, are not reflected in the company employee numbers stated above.

9. ULTIMATE CONTROLLING PARTY

In the opinion of the directors the company has no ultimate controlling party.

10. GOING CONCERN

The company is dependent upon the continued support of the Customer and Local Services ("CLS") Department of the Government of Jersey. The financial statements have been prepared on a going concern basis, which assumes that the company will continue in operational existence for the foreseeable future and has the continued support of CLS.

The present grant, operating on a rolling yearly agreement with CLS, continues to 31 December 2023 and whilst the grant for 2024 has not been agreed at the date of signing these financial statements, the directors are of the opinion that there are no indications to suggest the 2024 grant will not be paid. The existing service level agreement with CLS is in place until 31 December 2023.

The Directors are also conscious of and must draw attention to the operating loss which was incurred by the company during the year, and the company's expected future spending requirements. Whilst the Directors are aware of the reduction this has on reserves, the Directors are of the opinion that the company continues to maintain sufficient reserves to support the going concern assessment when combined with the points previously noted.

Having taken account of the above the directors are of the opinion that the company should continue to produce its financial statements on a going concern basis. In making this assessment they have had due regard to the adequacy of the undertaking for the provision of financial support by the CLS.

11. DONATED SERVICES

Included within expenses is an audit fee of £6,374 (2021: £5,329). The actual fee charged has been discounted by £4,685 (2021: £3,553). Also included within expenses is a fee for professional services of £2,940 (2021: £5,000). The actual fee charged has been discounted by £2,940 (2021: £5,000). These discounts are recognised in donations income in accordance with the company's accounting policies (note 2.4).

12. POST BALANCE SHEET EVENTS – BUILDING REFURBISHMENT

During the first and second quarters of 2023, the company has undertaken renovation and refurbishment work on the premises it occupies at St Paul's Community Centre in St Helier. The refurbishments required were significant and were undertaken to ensure the office space and infrastructure utilised by the company met the needs and requirements of the charity for the current and potential future levels of service.

The forecast final costs of the project, which are to be borne out of the current reserves of the company, are expected to be in the region of £100,000 - £105,000.
