

Privacy Policy – Websites

Your personal information and what we collect

We capture or store any personal information about you when you access our website in the form of your Internet Protocol Address (IP address). We will also store your email address if you subscribe to the site.

We also store names, job titles, contact numbers and email addresses of individual persons who work for the organisations whose websites are displayed on this website. This information is used to assist the general public in accessing services.

When you sign up for our services

We store your contact information to understand your needs and provide you with a personalised service.

We do not share the information you provide with any third parties and we protect it in accordance with the Data Protection (Jersey) Law 2018.

If you no longer wish to have your personal information on our site or you wish to up-date the information we hold, you can contact us on advice@cab.org.je and we will remove or up-date your information.

You can also contact us, in writing, to ask what information we hold about you. We will respond to your request within 30 days and you will be required to prove your identity in order to do this.

When you contact us

If you contact us asking for information, we may need to send your enquiry to other organisations in order to respond to your request.

Cookies

We use cookies on our website. Cookies are small files which can be stored on your computer when you visit a website. These files contain information about the webpages you look at so that the next time you visit the site it can be customised to meet your needs.

Links to other websites

Links on our website may lead to other websites which are not under our control. Using these links does not mean these organisations can access information about you which is held by the Jersey Online Directory or Citizens Advice Jersey.

This privacy policy only covers the Jersey Online Directory website (www.jod.je) and Citizens Advice Jersey site www.citizensadvice.je. Websites linked to, and from, these sites are not covered by this policy so you should always read the privacy statement on that website.

The websites are not responsible for the content of external websites.

Google Analytics

We use Google Analytics to help us understand how you engage with our website so that we can continually improve your experience.

When you visit the sites your browser automatically sends certain information to Google. This includes, for example, the web address of the page that you're visiting and your IP address.

IP address

Your computer's IP address is a number assigned to your computer when you use the internet. This is recorded automatically in a log file when you visit our site. This log file does not contain any personal identifiable information about you.
